After much deliberation and careful review of nationwide, and in particular the Charleston, SC, area COVID-19 infection data, both current and projected, and with the health and welfare of our members and guests as our paramount concern, your RAFINO Board of Officers has decided to delay the 2020 Reunion scheduled for 7-11 October, 2020, for 12 months until October, 2021. Our host hotel and excursion partners have informed us that they have open dates to accommodate us during the rescheduled time. We will advise you of the new dates as soon as coordination is complete.

In a recent survey sent out to registered participants regarding the possibility of a delayed reunion, there was close to unanimous support for allowing the

RAFINO Treasurer to hold already paid registration and event fees in the event the reunion was to be delayed by 6-12 months. By holding the already submitted payments and applying them to the new reunion, we will avoid further PayPal or credit card processing fees. Our hosting hotel and excursion partners have agreed to honor previously negotiated rates, including our group room rate of \$138.00 per room, per night for the new reunion dates. We will advise you soon as to what, if any, individual interaction with the hotel regarding moving room reservations will be. We will work with the hotel for a blanket movement of already made reservations. However, if any already registered and paid up member desires to cancel their registration now and not carry it over to the new dates, we will certainly refund you in full. If you desire a full refund, contact our Treasurer, Imre Volgyi, at: <u>thevolgyis@epbfi.com</u>. If you do decide to cancel your registration, you will be responsible for canceling your room reservations with the hotel.

I want each of you to know your Board did not take this decision lightly and we fully understand any disappointment or inconvenience this action may cause. However, as stated above, our number one priority in taking this decision is the health and welfare of our members, their families, and guests, of which many are in the COVID-19 "high risk" category. I hope to see each and every one of you in Charleston in October of 2021.

As for the 2022 Reunion currently planned for Indianapolis, the current Board of Officers will recommend to the new board to continue with the 2022 Reunion as planned, thereby adhering to our even numbered year cycle.

During the last quarter, we were able to recover over 70 percent of our unrealized losses that we encountered at the onset of the COVID-19 pandemic. As of June 30, we have total assets of \$114,119.15, with another \$23,662.10 in funds reserved for the Fall, 2021, Reunion (Advances of Registration Fees and Excursions). We continue to be doing better than the overall financial markets with our conservative blend of mutual funds.

We still have 114 members who are not current with their dues of which 19 will be dropped from our rolls this week. Normally, they would have been dropped on April 1 of this year, but we granted them an additional 90 days due to the pandemic with no one taking advantage of our generosity. In reviewing their last "log in" data, only two have even

logged into the RAFINO web site in the last year. There was another increase of 14 members from the last quarter who opted for the Life Membership, so we now have 286 life members, which represents 64 percent of our total members who are current in their dues.

Finally, we currently have 41 members and 72 attendees who are still registered and paid in full for the Fall, 2021 Reunion (four members with eight attendees will not be able to attend). Another 24 members and 44 attendees have begun but not finished the registration process for a grand total of 65 members and 116 attendees.

RAFINO is a fraternal/social Veterans' organization put together and run entirely for the enjoyment of soldiers who spent at least a large part of their Army life as Financial Management soldiers. Every Finance soldier eligible for retirement is eligible for membership in RAFINO. The organization offers a fun way to stay in contact with your friends and renew friendships with those whom you may have lost contact with over the years.

The original By-Laws were unanimously approved by the officers of RAFINO on the 31st of August 1987. The vote was based on mail replies of charter members the great majority of whom approved such formation of this society and the necessary steps to make it a non-profit veterans' organization.

The purposes above may be summarized in one word: fellowship. The two societies come together every two years for a festive reunion. Cities where the reunions have been held in the past include Washington, D.C., Indianapolis, Las Vegas, Ft. Jackson, Orlando, Williamsburg, Branson, Tacoma, San Antonio, Baton Rouge, and in 2018, Albuquerque. These venues offer a great opportunity to not only visit great spots in the U.S. but, as mentioned above, visit with old friends and meet some new ones.

On October 15, 2016, the previous sister organization, RAFINCO, merged its membership and assets into RAFINO, making the RAFINO the single place for all ranks of retired army finance soldiers.
